The Project "HortaFCUL" was created at the Faculty of Sciences of the University of Lisbon (FC-ULisboa) in 2009. It is directed by a group of students, interested in permaculture and how it can provide the solution for some of the environmental, social and economic problems.

With the support of the University and dedication of some volunteers, HortaFCUL has two distinct spaces. One is a vegetable garden with a mix of horticulture, aromatic herbs and fruit trees that is considered the heart of the project. In 2016, it was created a live laboratory of permaculture (PermaLab) at FCUL, a space to experiment and implement projects of permaculture and monitoring with scientific methodologies. This space is a result of the collaboration of HortaFCUL with the research centre cE3c, and FCUL, allowing the collaboration between all the community, promoting research-action and improving FCUL ecological footprint.

HortaFCUL is a project that invests in its social dimension. It considers it to be the vital matrix of its culture which supports the economic and environmental component of the project.

O projecto HortaFCUL foi criado na Faculdade de Ciências da Universidade de Lisboa (FCUL) no ano de 2009, dinamizado por um grupo de estudantes interessados na temática da permacultura e de como esta poderá providenciar solução para alguns dos actuais problemas ecológicos, sociais e económicos.

Com o apoio da FCUL e dedicação de alguns voluntários, a HortaFCUL tem neste momento dois espaços. Um jardim alimentício junto do edifício C2, um espaço que liga a agricultura ao jardim, com um misto de horticultura, ervas aromáticas e árvores de fruto, espaço este que é considerado o coração do projecto. Em 2016 nasceu um laboratório vivo de permacultura (PermaLab) na FCUL, uma zona que convida a implementação de projetos propostos pela permacultura e sua monitorização com metodologias científicas. Este espaço resulta de uma parceria entre a HortaFCUL, o centro cE3c e a FCUL, no sentido de fomentar a colaboração entre elementos da comunidade, promover a investigação/ação e melhorar a pegada ecológica da FCUL.

A HortaFCUL é um projeto que investe sobretudo na sua dimensão social, pois considera que é a matriz vital da sua cultura, que suporta a componente económica e ambiental do projeto.
